- Pickleball priority use at Bob Kildee Courts #5 & #6

District-run Programs/Events have priority use of all pickleball and tennis courts

Bob Kildee Community Park:

- First Come-First Serve
- When unreserved courts are full and others are waiting to play, courts cannot be used by the same four players for more than one game to 11 points or win by 2 points, but games must end at 15 points.

- 1. Cont. -Bob Kildee Community Park, Courts #2-6:
 - 1. Players waiting to get on an unreserved court should place paddles in provided rack, in order of arrival.
 - 2. When a game is finished, all four players will vacate the court.
 - 3. When one of the unreserved courts is vacated, those "Next Up" should move the paddle to the next position and take the court.



- 1. Cont. Bob Kildee Community Park, Court #1-Challenge Court:
 - 1. To use the Challenge Court, teams of 2 players place their paddles in the designated paddle saddle.
 - 2. There must be at least 4 challenge teams to sustain the challenge court, otherwise, the court becomes part of the other rotational courts (the same two challenge players cannot hold the court for more than one game).
 - Winners of a challenge match remain on the court to play the first challenge team. Winners can hold the court for a maximum of 2 games in a row, then must vacate the court. Two new challenge teams then take the court.
 - Challenge Court games are played to 11, win by 2 but games must end at 15 points.

2. Pitts Ranch Park:

- Install Paddle Saddles at both Parks
- First Come-First Serve
- When unreserved courts are full and others are waiting to play, courts cannot be used by the same four players for more than one game to 11 points or win by 2 points, but games must end at 15 points.

2. Cont. – Pitts Ranch Park:

- Players waiting to get on an unreserved court should place paddles in provided rack, in order of arrival.
- 2. When a game is finished, all four players will vacate the court.
- 3. When one of the unreserved courts is vacated, those "Next Up" should move the paddle to the next position and take the court.



2. Cont. – Pitts Ranch Park:

- 2nd Court becomes Multi-Use 4 total Pickleball Courts
- Begin a Shared, Priority Schedule with Tennis:

3. Springville Park – 2 Options:

1. Option #1:

- First Come-First Serve
- When courts are full, the following rules will be followed:
 - 1. The same four players no more than 30 minutes
 - 2. When a game is finished, players will leave the court promptly using the nearest exit.
 - 3. Players waiting to get on an unreserved court should place paddles in provided rack, in order of arrival.



3. Springville Park – 2 Options:

2. Option #2:

- First Come-First Serve
- When courts are full, the following rules will be followed:
 - 1. Waiting players secure their spot by placing their paddle in the saddle in order of arrival.
 - 2. Once a paddle is in the saddle, a two-game maximum play goes into effect for existing players.

3. Springville Park – 2 Options:

- **2.** Cont. Option #2:
 - 3. Existing players should finish their current game to 11 points or win by 2 points, but games must end at 15 points and can play a second game to a max of 15 points.
 - 4. After the second game, waiting players rotate in.
